Dear Chief Executive Officer,

Thank you for submitting Genesee County's Supervision and Treatment Services for Juveniles Program (STSJP) plan for Program Year (PY) 2021-2022. Your entire STSJP plan, including any amounts listed for PY 2021-2022 STSJP-RTA, has been **approved**.

The County is eligible to receive 62% State reimbursement for STSJP expenditures up to the capped STSJP allocation amount. Your municipality will continue to receive 49% State reimbursement for eligible detention services expenditures up to the capped allocation amount. If your municipality shifts a portion of its detention allocation into its STSJP plan, your municipality will receive 62% State reimbursement, up to the capped allocation, if such shifted funds are spent on STSJP eligible expenditures. A municipality may make a detention allocation shift at the time of the STSJP plan submission or up until June 30, 2022, unless otherwise approved by the Office of Children and Family Services.

If the County plans to shift its detention allocation for STSJP eligible expenses, please submit a request on official letterhead to Lynn Tubbs and email it to stsjp@ocfs.ny.gov outlining

1. the amount that will be shifted and
2. the type of programming or services the re-purposed detention funds will be used for under STSJP

Once the shift is approved, an amended STSJP plan will need to be submitted.

As a reminder, to access RTA reimbursement that a municipality may be eligible for, the expenditures must be specifically included in a locality's comprehensive RTA plan.

All STSJP claims, inclusive of STSJP-RTA, must be submitted electronically via the Juvenile Detention Automated System (JDAS) for the service period of October 1, 2021 to September 30, 2022. Genesee County has a population of approximately 60,000 people. Batavia and Leroy are the 2 largest cities, yet all youth in the County receive the same level of services. Being such a small County and primarily rural, we have about 13 zip codes including Batavia and Leroy. It is within the community of Batavia and Leroy where we see the most problematic children, however, the issues are not significant enough to a point where we need target these services as opposed to other areas in the County. Additionally, we are able to know our kids very well so there is no need to program for specific neighborhoods or communities. When we have approximately 150 youth in STAR, 30 PINS youth and 11 EM youth, we are able to know who they are and where they live and what school they attend. The local law enforcement in Genesee County work well with schools and other service providers to serve the entire Genesee County Community. Therefore, for the purpose of STSJP Planning, we are including all youth in Genesee County and not differentiating by a certain zip code.

b) If you identified any disparities when comparing youths' representation in the general population and their representation in detention and placement, explain how this plan will address those disparities. If you did not identify any disparities, please note such.

It is difficult to identify disparities when you look at a one-year snapshot in a small county especially when you are talking about detention admissions. In 2020 we placed one child in detention, and this was a Hispanic female. This makes it appear that Hispanic females are overrepresented by 100% in detention. Nonetheless we are aware that there have been prior disparities with minority populations. Additionally, it appears that in 2020 there is disparity in general population placement admissions for minorities in Genesee County. Genesee County is aware of the disparity that exists in general with the rate of placements. All staff are now required to attend Implicit Bias Training. Our probation officers (PINS) and our STAR Instructors as well as DSS staff are required to attend the trainings. Additionally, STAR, which works with the largest population of youth in the area strives to keep their Instructors at a minimum of 20% minority staffing. By hiring qualified instructors from this very community that also are diverse has shown to be beneficial to achieving cultural sensitivity. Although the higher rate of placement, the outcomes appear to be similar. This means that the minority youth are achieving their goals at the same rate as the non-minority children in placement. The goals of return to parent or discharge to independent living appear to be similar across racial and ethnic backgrounds.

B. LOCAL COLLABORATION

Collaborative efforts are made with various key components in Genesee County. Regular meetings are conducted between Probation and DSS as well as the County Youth Bureau and the provider agencies, like STAR. Genesee County has a rich history of local government departments, law enforcement and others to cooperate and collaborate regarding Juvenile Justice issues. Genesee County has a Juvenile Justice Planning Committee (JJPC) that meets on a monthly basis to review data and approaches to serving youth and families in the Juvenile Justice system. STAR (Program # 1) and Pins Diversion (Program # 2) thru Genesee County Probation are ATP Programs that have been successful over the years in preventing out-of-home placement of at risk youth. Genesee County Family Court also supports and recognizes the use of (ATP) Electronic Monitoring (Program # 3) as an effective way of keeping youth out of detention and safely in the community. We are also continuing our newest initiative called Juvenile Adjustment Services Committee (JASC) which has met every two weeks. This is different from JJPC in that

it will include the actual service providers in the area (Probation, DSS, Mental Health, School, Family) and we discuss case specific youth and how to best keep them out of any kind of placement. The JASC has shown to be successful so far.

The STAR program is designed to provide supervision, educational support, behavioral modification and many other positive developmental activities to youth that are at "high-risk" of out-of-home placement. Some youth in the STAR program have been adjudicated a PINS and/or JD and get referred to STAR by the schools, probation, DSS or the parent can self refer the child. The program work in conjunction with the parents/caretakers who are required to attend parenting sessions once a week. Additional allocation of funds will allow Genesee County STAR to increase its capacity of youth served and also allow for the STAR Instructors to make more frequent home visits and home checks for student who do not want to attend their school or program.

5. How does the average length of service compare to what you would expect for that service type? For ATD/ATPDP and ATP service types, compare with the average length of stay for youth who were in detention and residential placements during the same time period.

The average length of service remained pretty much consistent throughout each quarter. We find also that the children who enter a residential or detention placement, that the length of stay in one of those facilities is at least eight times as long. Having this alternative to a residential setting is essential to keeping children out of the lengthier congregate placements.

Goals are to keep children out of residential placement and to increase their school attendance and raise their GPA. Children in STAR during this past PY saw their grades go up by 12 percentage points and their absences drop from an average of 14 absences before STAR to an average of 10 absences while in the STAR program.

Some students failed to meet goals of STAR program. Non-compliance, failure for parent participation, assaultive behavior were some of the reasons for dismissal from STAR.

9. What changes have been made to overcome the barriers identified in Q8, so that the program can achieve its desired goals for PY 2021-2022?

Students who do not meet the desired goals are very few and far between. Mandated Preventive Services and other educational services or alternatives were subsequently provided to family, up to and including out-of-home placement.

The Probation Department's PINS Diversion program is designed to prevent out-of-home placements by engaging the youth, family and others, in the home, school and community. Many of the youth in the PINS Diversion Program are considered "high-risk" for further penetration into the juvenile justice system and eventual out-of-home placements. Officers coordinate services and referrals to counseling and/or community service and they track and monitor the progress of the child and can refer the matter to a judge for court supervision if deemed appropriate.

Electronic Monitoring (EM) is an ATD/ATPDP Program Serving both RTA and Non-RTA Youth. Genesee Co purchases the services from Behavioral Interventions. DSS staff receive alerts & act accordingly depending on nature of the violation.
