Dear Chief Executive Officer,

Thank you for submitting Saratoga County's Supervision and Treatment Services for Juveniles Program (STSJP) plan for Program Year (PY) 2020-2021. Your entire STSJP plan, including any amounts listed for PY 2020-2021 STSJP-RTA, has been **approved.**

The County is eligible to receive 62% State reimbursement for STSJP expenditures up to the capped STSJP allocation amount. Your municipality will continue to receive 49% State reimbursement for eligible detention services expenditures up to the capped allocation amount. If your municipality shifts a portion of its detention allocation into its STSJP plan, your municipality will receive 62% State reimbursement, up to the capped allocation, if such shifted funds are spent on STSJP eligible expenditures. A municipality may make a detention allocation shift at the time of the STSJP plan submission or up until June 30, 2021, unless otherwise approved by the Office of Children and Family Services.

If the County plans to shift its detention allocation for STSJP eligible expenses, please submit a request on official letterhead to Lynn Tubbs and email it to stsjp@ocfs.ny.gov outlining

1. the amount that will be shifted and
2. the type of programming or services the re-purposed detention funds will be used for under STSJP

Once the shift is approved, an amended STSJP plan will need to be submitted.


As a reminder, to access RTA reimbursement that a municipality may be eligible for, the expenditures must be specifically included in a locality's comprehensive RTA plan.

All STSJP claims, inclusive of STSJP-RTA, must be submitted electronically via the Juvenile Detention Automated System (JDAS) for the service period of October 1, 2020 to September 30, 2021. B. Municipality Level Analysis

1. The highest number of YO, AO, JO, JD & PINS youth reside in the cities of Saratoga Springs (Saratoga Springs City School District) and Mechanicville/Ballston Spa (Ballston Spa School District) along with the Town of Clifton Park (Shenendehowa School District). Of the 155 JD and PINS referrals received by Saratoga County Probation during this

time period, approximately 1/3 of the total number of referrals (46) came from the Saratoga Springs, NY area. The Mechanicville/Ballston Spa area follows with 26 referrals, and the Clifton Park area with 25 referrals for this time period. The remaining referrals came from approximately 13 other communities within Saratoga County, with 15 of those referrals being for youth that resided outside of our county.

Of the four youths who were residentially placed during this time frame, 75% were Black and Bi-Racial, 25% were white. These statistics are disparate from the demographics of Saratoga County whose population contains approximately 93% white persons and approximately 7% persons of other races/ethnicity. To address any racial/ethnic disparities, our collaboration with the agencies mentioned in this report will involve regular communication and particular attention to delivering services that provide fair and equal treatment to all youth during progressive stages of the juvenile justice system. We also endeavor to include the perspective of the youths/families in our case planning.

C. Local Collaboration

Saratoga County Probation and Berkshire Farm Center and Services for Youth meet monthly to collaborate through discussion of strategies and resources available to the youth of Saratoga County. DSS, various law enforcement agencies, the County Attorney, Mediation Matters, the Safe Harbor coordinator, CAPTAIN (and CAPTAIN Outreach) and our schools make themselves readily available via in-person meetings, emails, and phone conversations to discuss strategies and resources available. Furthermore, the juvenile Probation Supervisor collaborates in quarterly meetings and via emails with other Capital Region juvenile supervisors to discuss strategies and programs that are beneficial to our juvenile population.

The average length of stay is as we would expect for youth that have pending Family Court matters, which may also include pending pre-dispositional investigations and evaluations. Of course detention remands statutorily speed up the process and are typically comparable time-wise (10-20 days) to the length of stay with this ATD program, though this ATD program is also much more cost effective and allows the youth to remain at home to accomplish identified goals.

Stepping Stones requires a partnership with the county, family court, educational systems, law enforcement, and other County-designated agencies/parties. The partnership between Berkshire's Family Specialist and the child and family is an effort to keep children safe at home while addressing their issues.
