This report, prepared pursuant to section 20(5) of the Social Services Law (SSL), concerns:

- A report made to the New York Statewide Central Register of Child Abuse and Maltreatment (SCR) involving the death of a child.
- The death of a child for whom child protective services has an open case.
- The death of a child whose care and custody or custody and guardianship has been transferred to an authorized agency.
- The death of a child for whom the local department of social services has an open preventive service case.

The Office of Children and Family Services (OCFS) is mandated by section 20 of the SSL to investigate or cause for the investigation of the cause and circumstances surrounding the death, review such investigation, and prepare and issue a fatality report in regard to the categories of deaths noted above involving a child, except where a local or regional fatality review team issues a report, as authorized by law.

Such report must include: the cause of death; the identification of child protective or other services provided or actions taken regard to such child and child’s family; any extraordinary or pertinent information concerning the circumstances of the child’s death; whether the child or the child’s family received assistance, care or services from the social services district prior to the child’s death; any action or further investigation undertaken by OCFS or the social services district since the child’s death; and as appropriate, recommendations for local or state administrative or policy changes.

This report contains no information that would identify the deceased child, his or her siblings, the parent, parents, or other persons legally responsible for the child, and any members of the deceased child’s household.

By statute, this report will be forwarded to the social services district, chief county executive officer, chairperson of the local legislative body of the county where the child died and the social services district that had legal custody of the child, if different. Notice of the issuance of this report will be sent to the Speaker of the Assembly and the Temporary President of the Senate of the State of New York.

This report may **only** be disclosed to the public by OCFS pursuant to section 20(5) of the SSL. **It may be released by OCFS only after OCFS has determined that such disclosure is not contrary to the best interests of the deceased child’s siblings or other children in the household.**

OCFS’ review included an examination of actions taken by individual caseworkers and supervisors within the social services district and agencies under contract with the social services district. The observations and recommendations contained in this report reflect OCFS’ assessment and the performance of these agencies.

Presenting Information

The Administration for Children’s Services (ACS) received an SCR report on 5/28/2022, which alleged on the same date the mother (SM) fed the 5-month-old child (SC), laid him face down in the crib, and left the room. The mother returned approximately 30 minutes later and saw the child bluish in color and that he had spit up. The mother’s roommate (OA) called 911 and EMS responded to the home. The child was transported by ambulance to the hospital where he was pronounced dead. The father (BF) was not home at the time of the incident and had an unknown role. There were no other children in the household.

Executive Summary

This report concerns the death of a 5-month-old child which occurred while in the care of his mother. ACS received an SCR report regarding the fatal incident and coordinated their response with law enforcement.

Through interviews with law enforcement, the mother, the father, and the medical examiner, ACS learned the mother fed the child a bottle and placed him down for a nap. The mother placed the child on a couch, on his side or stomach, and left the room. The mother returned to the room approximately 30 minutes later and found the child on his stomach, bluish in color with spit up coming from his mouth. The mother yelled to her roommate for assistance, and the roommate immediately called 911 while the mother attempted CPR. The child was transported by ambulance to the hospital where he was pronounced dead. The father was not home at the time of the fatal incident.

The medical examiner informed ACS the mother performed a reenactment of the events, and the reenactment was consistent with her version of events. The preliminary autopsy results showed no signs of abuse or trauma present in the child. The final autopsy report was pending at the time the investigation closed.

The allegations of DOA/Fatality and Inadequate Guardianship against the mother were unsubstantiated. ACS offered the mother and father services in relation to the child’s death, which were declined. The mother and father moved out of state prior to the closure of the investigation. The final autopsy report was requested by ACS, and ACS documented they would make a new SCR report if information in the autopsy report warranted further investigation.

LDSS Response

ACS received the SCR report and coordinated their response with LE. LE informed ACS they had interviewed the SM and BF at the hospital. LE stated the SM fed the child and placed him to sleep on his side on a couch, not a crib as had been reported. The SM left the room to shower, and upon her return found him on his stomach, bluish in color, and he had spit up coming from his mouth. The family was staying temporarily with a friend of the BF's and were looking for their own apartment.

ACS interviewed the SM in their office after multiple unsuccessful attempts to meet with her in the home. The SM confirmed the events as reported to ACS by LE. The SM stated the SC had no medical or developmental diagnoses or special needs and the SC was born in Maryland, which was also where his pediatrician is located. The SM stated the SC was not yet rolling over on his own. ACS offered the SM services in relation to the death of the SC. The SM was initially receptive to services and later declined to participate in them. The BF was interviewed by phone and was reluctant to share details of the events with ACS or LE. The BF was not home at the time of the fatal incident and declined services when offered by ACS.

ACS performed a home visit and interviewed the OA. The OA stated the family had only stayed with him a few nights and he was a friend of the BF's. The OA stated he was in the living room and heard the SM scream for help. The OA immediately called 911 and EMS responded to the home. The OA had no further knowledge of the fatal incident.

ACS interviewed the ME. The preliminary autopsy results showed no signs of abuse or trauma in the SC. The ME stated the SM performed a reenactment for LE and the medical examiner investigator on scene. From the reenactment, it was possible the SC was placed on his stomach to sleep. The ME did not suspect any criminality and the SM's version of events was consistent with the reenactment and their findings. The final autopsy report was awaiting the toxicology results and was not available to ACS at the time the investigation was closed.

ACS interviewed the SC's pediatrician and obtained their treatment records. The SC's pediatrician identified no medical or developmental concerns for the SC and reported they were up to date with immunizations.

The allegations of DOA/Fatality and IG against the SM regarding the SC were unsubstantiated. The final autopsy report was requested by ACS, and it was documented a new SCR report would be made if information in the final autopsy report warranted further investigation. The family was offered services in relation to the death of the SC, which were declined. The SM and BF reported they had moved out of state and the investigation was closed.
